CHALLENGES CONCERNING ALIGNED ELEMENTS AND OHSC MEASURES AND PROPOSED SOLUTIONS

Challenge	Proposed solution
<p>Elements on ideal clinic framework are regarded as Non- negotiable vitals while on OHSC criterion they are vital measures and vice versa.</p>	<p>Align ICRM tool with OHSC tool to have the same outcome</p>
<p>Checklists for NNV’s do not align with one another e.g. Oropharyngeal airways, suction device and suction catheters are not counted as NNV’s in OHSC tool whereas in ICRM tool they are counted as NNV’s</p> <p>Availability of laryngeal masks for clinics</p>	<p>To align</p> <p>The NNV to be available in the resuscitation room than in the emergency trolley or put an asterisk that its needed only where there is a permanent doctor so that facilities are scored “Not applicable.’</p>

Challenge	Proposed solution
ICRM consists of three NNV elements, that is the emergency trolley, and oxygen cylinder with functional gauge, where as OHCS has the emergency trolley as the only NNV element	To include oxygen cylinder and functional gauge as NNV to OHSC or to remove the above from ICRM as NNV
Facilities achieving IC status are categorized as silver, gold or platinum, whereas OHSC is compliant with satisfactory, good or excellent	To align
